Bougainvillea House has been in operation for 12 years and prides itself on a whole life and family approach to healing. It is more than just a supervised visitation center with the licensed staff providing therapeutic visits and counseling in many different areas of concern based on client needs. Monthly family therapy is required for all participants as the goal is to achieve healthy family reunification. Once children are involved in counseling, counseling services are also open to parents in a variety of areas, from depression, anxiety, and substance abuse to parenting.

Our offices are open until 8:30 each evening to be sure kids don't have to miss school or perhaps their free meals to attend. The center is a complex of 5 houses which provide a homey, more natural setting for visits. There are also yards to play in for outdoor fun.

Bougainvillea House does extensive community outreach, particularly in local schools to help educate students on mental health anxiety, depression, violence, substance abuse, self-harm, and other issues that may come up in the family setting. We want them to understand the issues and also know that we are available with all the resources they need to remain happy and healthy.

In addition to supervised and therapeutic visitation, we over-monitored exchanges. For the sake of safety, staff go out to the client's car to get the kids, then walk them in. Keeping kids and custodians safe is a priority, and on-site security personnel are used as needed.

At Center for Attachment & Trauma, we provide innovative services to families where traditional services have failed. By responding to complex developmental trauma with an attachment-based, trauma-informed approach, we strategically address the underlying emotional dynamics of the family, supporting the healing of the source of childhood trauma—the parent-child relationship.

All of our clinicians have been serving as therapists with extensive juvenile dependency experience and are trained in Trust-Based Relational Intervention and Adoption Competency. We are a skilled team comprised of advocates, former case managers, former Guardian ad Litem, attorneys, professors, foster and adoptive parents, and licensed clinicians.

We offer all services in-person and virtually throughout Circuits 6, 9, 13 and 18 in English, Spanish, Haitian Creole and Brazilian Portuguese.

THERAPEUTIC SUPERVISED VISITATION (TSV)

Therapeutic Supervised Visitation is designed for supervised visits in cases involving more complex challenges such as domestic violence, verbal abuse, or other parenting difficulties. It is particularly valuable in situations involving allegations of sexual abuse, the risk of child

abduction, or parental alienation. This program focuses on guiding parent-child interactions in a safe, therapeutic setting, enhancing the parent-child relationship.

Each visit includes a pre-visit session to prepare and set goals while addressing concerns raised by either the parent or child. Post-visit sessions provide opportunities for feedback, reflection, and continued support in nurturing the relationship. Therapeutic Supervised Visitation happens within the context of supervised visits, ensuring safety and structure during family interactions. Visits may take place in various settings, such as homes, parks, libraries, resource centers, or virtually, depending on the family's specific safety needs and convenience. HIPAA-exempt documentation is provided to the CMO to support informed judicial decisions, based on observed behavioral changes during visits.

VISIT COACHING

Visit Coaching supports parents in developing attuned and responsive interactions that meet their child's needs in the context of unsupervised visits. This child-needs-focused approach emphasizes understanding the parent and child's underlying emotional dynamics, fostering the child's long-term development. Visit Coaching includes pre-visit sessions to prepare for the visit, discuss goals, and address concerns, ensuring a positive and consistent visit experience. Post-visit sessions provide an opportunity for reflection and feedback, supporting both the child and the non-custodial parent. Visit Coaching frequently includes the caregiver to enhance the co-

parenting relationship between the non-custodial parent and the caregiver, minimize the child's dysregulation associated with visitations, and alleviate loyalty pressures often felt by the child.

This service often includes non-custodial parents to strengthen co-parenting, minimize the child's emotional dysregulation related to visitations, and reduce feelings of loyalty conflict. Comprehensive, non-HIPAA-bound documentation is provided to the CMO, offering detailed insights into behavioral changes during visits to aid judicial decision-making.

SUPERVISED VISITATION

This service is available for cases that require therapeutic observation without the need for direct therapeutic intervention. Understanding that one goal for parent-child visitation is gathering observations of safety concerns, the parent-child dynamic and any progressions in behavioral changes, we offer supervised visitation to ensure that this data is through a therapeutic lens. Supervisors apply their trauma-informed, attachment-based knowledge to document the event of the visit and offering recommendations to case manager for additional services, if necessary.

The 2024–2025 year has been another successful one for ChildNet's Visitation Centers in Broward and Palm Beach. Our interns, who are pursuing either their bachelor's degree in human services or master's degree in social work, have contributed greatly to enhancing the quality of visitation services.

Throughout the year, we hosted a variety of themed activities to make visits meaningful and engaging for children and families:

- Halloween: Staff dressed as superheroes and Disney characters while handing out candy to families.
- Thanksgiving: Children participated in coloring "thankful" projects for their families.
- Christmas: Families decorated the Christmas tree with paper ornaments created by the children.

The Family Visitation Center of the Children's Home Society serves the visitation needs of parents and children in the dependency court system of District 11, and has always done so completely without charge to the parents. We provide both supervised and therapeutically supervised visitation for families. We view as our greatest accomplishment the positive role we play in aiding in the re-unification of families and children by providing a safe, homelike environment for visitation.

We normally have a constant stream of interns from the FIU School of Social Work, many of whom continue as hired staff. Although we have returned to normal operations post-covid, we do still include the provision of toys the kids can simply take home with them!

CHS has instituted a new "Warm Line." As opposed to a "Hotline," this Warm Line is not just for emergencies but any time someone needs to talk. The Warm Line offers 24-hour clinical services – someone to talk to. This service has been a great resource for the whole agency as well as SV clients. The project is going exceptionally well and is offered to not only CHS clients but the entire community. It is currently staffed by trained, licensed clinical staff from around the state.

CHS Supervised Visitation program offers the Nurturing Parenting curriculum as well as parenting education. This is a revolving 10-week course that is done weekly, virtually. They learn about brain development, so they have proper expectations for their kids. It also helps parents in their own coping skills. This helps them understand their children's behaviors and how to manage those behaviors in a loving, appropriate way. Our services are mainly in-person visits, but we are offering virtual visits when requested. We do in-center visits only.

In our newest building we continue to host fun events, including holiday parties for the children. We are decorating for the holidays to help families enjoy the season. Parents are encouraged to bring seasonal items and activities to the visit.

Our center is an inviting, homelike place with playrooms, a kitchen, living areas, conference rooms, and a playground outside -a more natural environment than the average case worker's office. Because of the warmth of our center, we have been very successful in making families feel comfortable to really enjoy time with each other. One parent who was doing visits in a caseworker's office was really struggling – her numerous kids were antsy, sometimes noisy, and the whole situation was stressful for her. She even started missing visits. However, when

We continue to offer in-person visits and still offer virtual visits for those that need or want them. Our wonderful and resilient staff have also done a terrific job of balancing both in-person and virtual visits. In one case, a mother was very concerned about her baby being exposed to the covid virus, so we agreed to have her in-person visits outside of regular hours when no other families were around. This case continues with great success! We reunified a family that refused visits in person. She agreed to virtual which helped and are now reunified

We have continued using virtual visits in additional ways. Judges are sometimes ordering virtual visits for a time period *before* allowing in-person visits as a transitional option. In some cases where there is a strained relationship, this allows us to move slowly to in-person visits, which might be uncomfortable right off the bat. It has been a wonderful solution in several cases. In one case where the last interaction of the parent and child had been tense and uncomfortable, they were able to do a series of virtual visits to work through some issues before actually visiting in person to enjoy each other's company. In another case, a mother and her young baby are doing virtual visits with extended family members so the child can see them and meet them before actually seeing them in person. This strategy allows the child to acclimate gently. In yet another case, the child refused to visit in person but did agree to virtual visits. Through a series of virtual visits, the child and parent were able to reconnect gently and then move to in-person visits. We're proud to report this family is now happily reunified! Judges will continue to utilize virtual visits in this way, and we continue to offer it as an option for cases.

This coming year, we will be working with a judge's request to video tape visits. This will be a new endeavor and we're researching ways to keep the camera non-intrusive. Our environs change decorations seasonally and with each holiday. We're now transitioning to fall and Christmas when we hope to host a Gingerbread house decorating contest. In addition, we'll make goodies bags for each child to take home for the holidays!

The Visitation Coaching Program serves the supervised visitation needs of parents and children in the dependency court system of Circuit 5. There is no charge to the parents. We receive referrals from case management and recommendations from the court to highlight the areas of need. There are currently 2 visitation coaches with extensive experience working with families. One is bilingual, Spanish and English. The Visitation Coaching program provides the children and parents with books, puzzles, board games, and a variety of activities to make the visits a positive experience. The parents are encouraged to provide food for the children and talk while eating together to enhance and rebuild their bond. An important component during the pre-visit and post-visit is to allow the parents time to discuss their thoughts and feelings, discuss any barriers, and plan an activity for their children. Materials, videos, and modeling are tools used to enhance diminished protective capacities. The

visitation coaches offer suggestions for age appropriate engagement and ways to strengthen the bond with their children. The parents are encouraged to put the children's needs first.

Before starting any services, an agreement is signed by the parents and coaches to emphasize the expectations and guidelines within the program. The coaches participate in staffings and court hearings regarding the parent's case plan goals and tasks needed to achieve reunification with their children. The program is usually approved for 10 visits, but an extension or brief assessment may be granted based on the individual families' needs and progress. Due to Covid-19 visits by Zoom were added to facilitate parent-child contact and continue to be used if one or the other is sick or residing out of state.

The visitation coaches provide creative ways to reassure and inspire parents to continue visiting and planning for their child's permanency. In many instances activities are provided that are age appropriate by bringing them to the visits or providing them at our visitation rooms. This is to show the parents a variety of activities that the child may enjoy and utilize. On some occasions, we give toys for children as they leave the visit, so the ride back is not as stressful for them. TBRI strategies are used to empower parents on building connections and build trust with their children to have more success in behavior correction and discipline. We often give information to parents about services in our community to address specific needs like DV shelters, government funded apartments, daycare services, etc. We also inform our staff about our program and give suggestions on how to assist other families in our agency.

The Visitation Interaction Program is designed to strengthen and/or repair the relationship between parents and children in out-of-home care where reunification is the goal, and the court has ordered visitation. It focuses on making visits child-centered, with the parents engaging in a positive manner with the children. It also allows visits to occur in the most homelike setting possible. Staff are available during normal business hours, but services to families are provided at dates and times that best suit the families and their schedules.

Through the Visitation Interaction Program, parents learn how to make visits a positive experience. They learn techniques and are provided tools to help them meet the needs of their children. The Program strengthens the child's relationship with the parent.

The coaching process begins with the completion of the Adult Adolescent Parenting Inventory, which provides an index of risk in 5 domains: expectations of children, parental empathy towards children's needs, use of corporal punishment, parent-child family roles, and children's power and independence. The AAPI is completed before working with the family and at the conclusion of the Program to measure progress.

Each visit consists of a pre-visit prep session where the coach and parent develop goals for that day's visit, observation and coaching during the visit itself on areas identified as needing improvement, and a post-visit feedback session to discuss where the parent did well and needs more coaching.

Since program inception, AAPI scores reflect an overall average improvement of 1-5 points in each domain for clients. Customer satisfaction surveys reveal parents enjoy having their visits outside of the office and developing a stronger bond with their children. The Program has also shortened the length of stay in out-of-home care and increased the likelihood of the child being reunified (versus families not involved in the Program).

The Visitation Interaction Program was the recipient of the Innovator of the Year Award at the Children's Home Society of Florida's 6th Annual Innovation Symposium in 2012. The Symposium is dedicated to finding better ways to serve children. This Program was selected due to its successful outcomes and ease of replication.

We do a special Thanksgiving drive to provide dinner for families in need as well as a toy drive to give presents to children who might not otherwise have any Christmas gifts. In addition, we collect bookbags and school supplies for our kids and are part of the Bags of Love network helping kids 1mo to 18 years old which includes bags with a pillow, comforter, a stuffed animals, personal supplies, etc. to make sure they feel loved and comforted. We also collect donations for new homes such as dishes, housewares, and furniture.

Thriving Families offers a chance for reunification of child(ren) and their parent and/or other family members under the circumstances of divorce or the absence of the parent due either to choice or otherwise. Thriving Families was developed so that children can have a safe, secure place to rebuild broken bonds when supervised visitation has been court ordered. The Buggy Bunch has implemented a system with the Thriving Families program where a supervised visit or exchange is provided with proper security by a paid law enforcement officer. In addition to security, TBB provides trained facilitators who observe through sight and voice and in a secure atmosphere during the supervision period.

Referrals for the program usually come from the 19th Circuit Judicial Court System. The visitation between the non-residential parent and the child lasts for 1-2 hours and are either weekly or biweekly. The Learning LOFT is provided at The Buggy Bunch Family Center for the non-residential parent and child to use. Contact between the residential parent (RP) and the non-residential parent (NRP) is not permitted. This is accomplished by staggering time for drop off and pick up of the child and overseen by the security officer. Thriving Families also offers a court-ordered Monitored Exchange Service that allows parents to make safe exchanges for their children. Benefits include: shared parenting time, reduced stress for parents and children, security, and a neutral third party.

As a Court-Ordered Supervised Visitation Program, Thriving Families makes it possible for parents to receive safe and secure visitation with their child(ren) in one of three ways: one-to-one supervision, monitored exchanges and/or group supervision. This is accomplished through striving for best practices and achieving our primary goals, which are: 1. Secure Visits, 2. Nurturing Atmosphere, and 3. Education and Awareness.

This much needed program was created and exists for several reasons: to build parent capacities, to provide parents with evidence-based research and strategic plans, to implement the 6 Protective Factors established by the Supervised Visitation Clearinghouse, and to give parents developmental skill-building plans to strengthen and improve family bonds and relationships.
